

EMERGENCY FINANCIAL ASSISTANCE PROGRAMS RE: COVID-19

DSHS WA STATE:

Disaster Cash Assistance Program Available at DSHS

People can apply for DCAP online at <u>WashingtonConnection.org</u> and then call the Customer Service Contact Center at 877-501-2233 to complete the required interview. People can also call 877-501-2233 to complete the entire application process over the phone. Due to much higher than normal call volumes, people are asked to call before 11 a.m. and to keep in mind that the busiest call times are 11 a.m. to 2 p.m.

This cash assistance is available to Washington residents regardless of citizenship status, and does not require applicants to provide a Social Security number. Eligible households will receive their DCAP benefits for one month in a 12-month period during an emergency. The benefit amount depends on household size, income and need, ranging from a maximum of \$363 for a single person to a maximum of \$1,121 for a household of eight or more people. Once approved, people will receive their DCAP benefits on an existing Electronic Benefit Transfer, or EBT, card or a new EBT card will be sent via U.S. Mail.

BREMERTON HOUSING AUTHORITY

RENTAL ASSISTANCE for TENANTS inside the City Limits of Bremerton ONLY. BHA has two rental assistance programs happening currently for those NOT on a Housing Program, within the income limits and in the city limits of Bremerton. Requirements are on the website links.
