- **Jon Pearson** announced Central Kitsap “Family Night” being held at the Kitsap County Fairgrounds President’s Hall on April 26, 2007 from 4:30 PM through 7:30 PM.

- **Commissioner Brown** introduced new Kitsap County Administrator Nancy Buonanno Grennan.
- **Jon Pearson** had the Second Reading and Vote on Bylaw Amendment. **M/S/C** to approve Article V, Section 1 as presented. (Written report in file.)
- **Commissioner Brown** introduced Steve Rice and Robert Hutchinson from Rice, Fergus, Miller Architecture.
- **Steve Rice and Robert Hutchinson** proceeded with the Community Campus Presentation. (Written report in file.)
 - Discussed connectivity between parcels.
 - Importance of timing, phasing and building on-site. Long-term plan is 15 to 20 years till completion.
 - Community Campus will be ecology sensitive with green designs.
 - Availability of underground parking combined with stand alone parking during the various building phases.

- **Commissioner Brown** commented on future accommodations for CSTOCK, and other organizations due to necessary long-term capital needs for the Silverdale Community Center building.
