**ESTABLISHING THE MANCHESTER CITIZEN ADVISORY COMMITTEE**

**WHEREAS**, the Kitsap County Board of Commissioners advocates public participation and supports and encourages citizen involvement in all matters of County government; and

**WHEREAS**, a group of Manchester citizens diligently worked on the December 31, 2007 Manchester Community Plan which encouraged the creation of a Manchester Citizen Advisory Committee to represent the citizens of Manchester in furthering of the plan's goals and policies; and

**WHEREAS**, on September 4, 2008, members of the Manchester Community Council forwarded a recommendation to the District #2 Commissioner regarding the structure of the committee and requesting immediate action to seek citizens interested in serving on the committee; and

**WHEREAS**, the Board of County Commissioners are empowered to create advisory boards by the general governmental powers with which county legislative bodies are vested.

**NOW THEREFORE BE IT RESOLVED BY THE KITSAP COUNTY BOARD OF COMMISSIONERS** that the Manchester Citizen Advisory Committee is established to represent the citizens of Manchester in furthering the goals and policies of the Manchester Community Plan.
