The application of Debbie L. Harp for Current Use Assessment - Open Space on 8.62 acres in Section 31, Township 27, Range 2E, in North Kitsap County. The property does not qualify for Agricultural Land since it does not meet income requirements to be eligible for the program. The property is zoned Rural Protection, one dwelling unit per 10-acres. The property is located at 4493 NE Stevens –Uhler Road in North Kitsap County.

The application of Gale T. and Kay Gray for Current Use Assessment - Open Space on 8.36 acres in Section 02, Township 26, Range 2E, in North Kitsap County. The property does not qualify for Agricultural Land since it does not meet income requirements to be eligible for the program. The property is zoned Rural Residential, one dwelling unit per 5 acres. The property is located at 23052 Tulin Road in North Kitsap County.

The application of Darren W. and Suzanne M. Glazer for Current Use Assessment - Open Space on a 3.36-acre portion of 10 acres in Section 02, Township 22, Range 1E, in South Kitsap County. The property does not qualify for Agricultural Land since it does not meet income requirements to be eligible for the program. The property is zoned Rural Residential, one dwelling unit per 5 acres. The property is located at 87 Pine Road in South Kitsap County.

The application of Steve and Wilma Childers for Current Use Assessment - Open Space on 3 parcels totaling 10.01 acres in Section 34, Township 24, Range 2E, in South Kitsap County. The property does not qualify for Agricultural Land since it does not meet income requirements to be eligible for the program. The property is zoned Rural Residential, one dwelling unit per 5 acres. The property is located at 3030 Long Lake Road SE in South Kitsap County.
