Delivery Vehicles: NO CHARGE - One delivery vehicle pass per vendor. Only permitted vehicles will be allowed on grounds from 6am-9am daily for re-stocking. All passes must be visibly displayed in the window. Vehicles on grounds after 9:15am are subject to penalty and/or immediate towing. Whenever possible, vendors are encouraged to walk their deliveries in. Load/Unload zones will be set-up for easy access. Hand trucks and wheelbarrows are available, on a first come, first serve basis, free of charge at the Fair Office to assist you. Thank you for helping to minimize traffic and create a safe environment on our fairgrounds. **Check box if permit needed:**

Last Day Vehicles Permit: NO CHARGE –If you plan to dismantle your booth beginning at 8:00pm closing night, you will need this permit to enter the grounds. **No vehicles will be allowed without a permit or until ALL pedestrian traffic has been cleared and Fair Management has given clearance for vehicles to enter.** ANY VENDOR WHO ATTEMPTS TO ENTER PRIOR TO THIS CLEARANCE WILL BE DENIED SPACE IN FUTURE FAIRS. THIS IS A SERIOUS SAFETY ISSUE! A public address announcement will be made when vehicles are allowed. Move out is scheduled by area. Additional information will be found in Participates Guide, which is received at check in. One permit per vendor. **Check box if permit needed:**

Camping: Permit Is Required For All Camping On The Grounds. This will be very strictly enforced. The fairgrounds have very limited camping available. Power and/or water may available in some areas, but is not guaranteed! All units should be self-contained. There is a dump station on site available for dumping only prior to opening day of fair and after 9:00pm closing day. Please contact the Fair Office at (360) 337-5350 for a camping application or further information.
