- NO OPEN CHARCOAL BARBECUES – PROPANE ONLY. You will be warned if using an open charcoal barbecue; if used again it will be confiscated and returned after the Fair.
- FIRE EXTINGUISHERS ARE REQUIRED.
- For safety purposes you are signing this form to give permission to access your vehicle in case of an emergency (i.e. fire or danger to others).
- **PASSES WILL NOT BE MAILED!! ALL PASSES MUST BE PICKED UP PRIOR TO OPENING DAY OF FAIR.**
- Pass orders will be available for pick-up beginning the first Thursday in August.
- Orders are available for pick-up at the Parks & Recreation Office, Monday – Thursday, 8:30 a.m. to 5:00 p.m.
- Or at the Fair Information Office (White House near the Dog Barn) on the Tuesday of Fair week from 10:00 a.m. to 9:00 p.m.
- All passes MUST be picked up prior to opening day.
