

CYNTHIA TRENSHAW: QUALIFICATIONS, BACKGROUND AND TRAINING

I received national chaplaincy certification (NACC #109960), after 1600 hours of study, in 1993. For three years I served in a 210-bed nursing home as its professional chaplain. I was on-call chaplain for a city medical hospital, serving the Emergency Room, Intensive Care, Oncology and Psychiatric units.

I served as a trainer for volunteers and nursing assistants in Hospice of Greater Grand Rapids and Mercy Healthcare Systems.

I earned a Masters Degree from Jesuit School of Theology at Berkeley in 1998, and national certification (NCBTMP #153994) as a massage therapy practitioner in 1999.

For five years I served homeless people on the streets and in the shelters of San Francisco.

In May of 2004 I received certification as a Nursing Assistant -- Registered (#NA00164632). I have served as an in-home caregiver for Island Home Nursing, and as a personal caregiver for Enso House residential hospice.

Beginning in 2005 I have served as Durable Power of Attorney for Healthcare and for Finances, and as a Medical Advocate for an increasing number of private clients.

In 2003 I took the King County Bar Association/Washington Supreme Court state guardianship training; in January of 2004 I received my Professional Guardian Certification (CPG #10265) and since have been appointed to several Title 11 guardianship cases in Island County, serving impaired elderly people, persons with physical and mental illnesses, and other incapacitated persons. I have fulfilled all Continuing Legal Education requirements each year.

In May of 2006 I completed the Title 11 Guardianship Guardian Ad Litem training from the King County Bar Association, completed my practicum in October of 2006, and was added to the Island County GAL registry. I have fulfilled all annual CLE requirements.

In July 2007 I was added to the San Juan County GAL registry.

In July 2009 I was added to the Kitsap County GAL registry.

In September 2010 I was added to the Skagit County GAL registry

As of January 2011, I have served seven GAL appointments in Island County, eight in Kitsap County, and one in Skagit County.
