Two still at large in Hood Canal residential burglary

Port Orchard, Wash. -- With five suspects now in custody, two having been arraigned and charged in court, sheriff's detectives are focused on completing the 'round-up' of two remaining suspects, still at large, wanted in connection with a residential burglary to a home on the Hood Canal, west of Silverdale.

Felony warrants of arrest have been issued by Kitsap County Superior Court for the apprehension of Gregory Lawrence Burton, age 35, and Michael Alan Carter, age 27. The warrants are for residential burglary, with bail set at \$250,000 each.

Both are known to reside in the King County and Snohomish County areas.

The burglary was discovered during the early morning hours of Jan. 12 by family members. Stolen property from the burglary included a substantial amount of jewelry, clothing items, credit cards, electronic items and a 2008 Cadillac STS sedan. Total value of the stolen property exceeded \$1 million.

Through the course of the investigation, sheriff's detectives have recovered approximately \$500,000 worth of the stolen property and the stolen Cadillac.

Two of the suspects in custody, Lori Jo Devier, 51, and Jacquelyn Azure Elzea, 20, were arrested by sheriff's detectives late in the evening of Jan. 25, when a search warrant was served at Devier's residence in Everett.

On Monday Devier and Elzea were arraigned and charged in Kitsap County Superior Court with residential burglary and theft, 1st degree. Bail amounts for both were increased by the judge from \$100,000 to \$200,000.

Kitsap County Superior Court warrants of arrest for residential burglary also have been served on Dylan James Downey, 24, previously of Kitsap County and now of Everett; Stephen Mathew Sundstrom, 19, of Everett, and Phaalen Alexandria Riall, 23, of Seattle, in connection with this investigation. These three suspects are in custody in the Snohomish County Jail on charges from law enforcement agencies in that jurisdiction.
