David Forte and Melissa Mohr from the Transportation Improvement Program (TIP) provided a TIP update. The program covers 2023-2028. Road funding for the program comes from fuel tax, property tax, transportation impact fees, grants and a few smaller funding sources. Maintenance and preservation is the priority for all funds. Waste Management shared an update about a trash compactor failure at the Bremerton Transfer Station that has impacted their ability to pick up trash. It is also closed to people dropping off trash. It has been resolved as of today.

Carrilu Thompson shared that the Flea Market will be the first Saturday. MCA is looking for booths (\$40)! They will meet at Port Orchard library while Manchester is closed.

We received the updated zoning use table. MCAC feels that their suggestions were ignored regarding the zoning updates. Carrilu Thompson feels that the community comments were not considered adequately. Jennifer Haro shared that every comment made was read and discussed by the committee at a public meeting. Many comments were read and appreciated by the committee but were not influential in code changes.

The group discussed ways the table could be easier to read in the future.

Jamin Mason, vice chair of the People's Party of Washington, asked if the zoning changes would affect the homeless shelter on Mile Hill. He was told it wouldn't. He said he supports the shelter.

Ana Langone has applied for the business MCAC position.
