- 5) **Centering moment** provided by Marcie – Read an excerpt from Rev. MLK Jr. speech at Birmingham

- 6) **Approval of Minutes** from previous meetings of June 15, 2021 – Marcie motioned. Susie seconded. Unanimous approval by the Council.
- 7) **Guest introductions, comments, or announcements** (three minutes each) – The Council had over a dozen guests that came to the meeting. These residents, former church members, protest organizers, concerned citizens, and representatives from local organizations came to share their concerns and educate the Council regarding Joseph Backholm, a contentious figure who participates in prejudicial viewpoints, hate speech, and sometimes aggressive tactics to make his point, who is set to speak at Gateway Fellowship Church in Poulsbo the following Sunday, August 22nd. Many of the guests, including the protest organizers (members of the Church) made it clear that they are not in opposition to the Church itself, but rather the ideology of the guest speaker. Nearly all of the guests in attendance requested that the Council make a statement of objection to Backholm spreading his messages within the community and of affirmation for the kind of inclusive community that we envision Kitsap to be.

12) New Business – The Council deliberated how to respond to requests made by multiple guests in the first hour of the meeting. After considerable research and discussion focused largely on: Backholm's ideology and history; Gateway Fellowship church members' attempts to directly prevent the speaker's presentation; Kitsap County officials' recent statements regarding racism; and the role of freedom of speech as opposed to the crime of hate speech, Chris motioned and Susie seconded that the Council approve issuing a public statement objecting to Joseph Backholm's ideology and spreading of it on a speaking platform within our community. Darrell recused himself because of a conflict of interest resulting from his relationship with the host church. The remaining Council members unanimously voted in favor of issuing a public statement. The Outreach Committee will write a draft statement and email it to the Councilors on August 18 for final review and edits. Once there is consensus, the statement will be sent to the Board of County Commissioners with the hope of its being approved for release no later than Thursday morning, August 19, so that it precedes the scheduled presentation.
