Ballot Measure District Responsibilities

Measure Arguments

Local districts requesting ballot measures are required to appoint committees to write arguments for and against each measure by the last day to submit the resolution. The district should appoint people known to favor the measure and appoint people known to oppose it.

Each committee can have as many as three people appointed. If the district fails to appoint a committee, the county auditor will attempt to make the appointment. [RCW 29A.32.280](#)

Ballot Titles and Explanatory Statements

Each district requesting a ballot measure will submit a ballot title with the resolution requesting an election. The district is required to also submit an explanatory statement prepared by the attorney for the district. [RCW 29A.32.241](#)

Filing for Office

Candidate filing week is May 14 – 18

Filing Electronically

RCW 29A.24.040

Online filing allows candidates to submit their forms electronically and pay their filing fees using a credit card.

Electronic filing begins at 9 a.m., May 14 and ends at 4 p.m., May 18. For more information visit: bit.ly/KitsapElections

Filing In-Person

RCW 29A.24.050

Candidates may file **in person**, 8 a.m. to 4:30 p.m., May 14 – 18 at the Kitsap County Auditor's Office.

File by Mail or Fax

RCW 29A.24.081

- Candidates may file in advance **by mail** beginning April 30.
- Candidates may file **by fax** from 8 a.m., May 14 to 4:30 p.m., May 18.
- Applicable filing fees are due by the close of candidate filing – 4:30 p.m., May 18.
WAC 434-208-060

Where to File for Office

RCW 29A.24.070

- Candidates for federal and state offices file with the Secretary of State, with the exception of 23rd Legislative District candidates, who file with the Kitsap County Auditor.
- Candidates for Supreme Court and Court of Appeals file with the Secretary of State.
- Candidates for countywide offices, including the Kitsap County District Court, file with the Kitsap County Auditor.

Filing Fees – all filing fees are non-refundable

RCW 29A.24.091, RCW 29A.24.131

Fees are based on the salary of the office at the time of filing.

- The filing fee for an office with a salary of more than \$1,000 is 1 percent of the annual salary.

Example: The filing fee for a position with an annual salary of \$40,698 is \$406.98.

- There is a \$10 filing fee for offices with a salary of \$1,000 or less.
- There is no filing fee for unpaid positions.

Petition in Lieu of Fee

RCW 29A.24.091

Candidates who lack sufficient income to pay the filing fee may submit a Nominating Petition. The petition must contain one signature for every dollar of the filing fee. Signatures must be of registered voters in the district you are filing for.

Example: A petition submitted for a \$406.98 filing fee must have 406 valid signatures of registered voters within the jurisdiction of the office.

Filing for Office

Residency Requirements

- At the time of filing for office, candidates must be registered to vote in the district represented by the office they seek, with the exception of **Superior Court Judges**, who may reside anywhere in Washington state. [RCW 2.08.200](#), [RCW 42.04.020](#), [Washington State Constitution, Article 2, Section 7](#)
- **County Commissioner** and **Public Utility District Commissioner** candidates must reside within the **defined internal boundaries** of the district.

Special Filing Period

If no candidate files for a position that is scheduled for election by the deadline to withdraw, the county Auditor will call for a special three-day filing period. [RCW 29A.24.181](#)

Partisan Offices

If after the special three-day filing period no candidate files for a partisan office, the vacancy is filled by appointment and is open for filing the following year.

[RCW 29A.24.191](#)

Nonpartisan Offices

If no one files for a position after the special filing period, that position will not appear on the Primary nor General Election ballots. The incumbent is designated to serve until the next election held for that jurisdiction.

Write-In Candidates

Write-in votes can only be counted for candidates who file a declaration of write-in candidacy. Write-in candidates may file for free after candidate filing week until 18 days before an election.

Beginning 18 days before an election and ending at 8 p.m. on Election Day, fees apply.

- \$25 for elected positions paying less than \$1,000 annually.
- 1% of salary for elected positions paying more than \$1,000 annually.

Write-in Votes

Write-in votes are not required to be tallied unless the total number of write-in votes could affect the outcome of the contest.

[RCW 29A.60.021](#)

Withdrawal Period

Any candidate who wishes to withdraw his/her candidacy must do so in writing no later than 4:30 p.m., May 21, the Monday after filing week. Filing fees are not refundable. There is no withdrawal period for declarations filed during a special filing period. [RCW 29A.24.131](#)

Washington State Declaration of Candidacy

how to complete the form

1. candidate information

Your name and address must match your voter registration. Update your voter information prior to submitting a declaration of candidacy.

You are responsible for ensuring that you meet all qualifications of the office.

2. campaign information

If you do not provide campaign information, your information as a registered voter will be used. A telephone number, email address, or website is not required, but recommended.

Government office addresses may not be used for campaigns.

3. ballot information

Print the jurisdiction, the office name and any position or district number defining the office for which you are a candidate. The responsibility for filing for the correct office is yours.

Print your name exactly as you wish it to appear on the ballot. Nicknames are acceptable.

Titles denoting occupations, including military rank, positions on issues, political affiliation, symbols, or anything intentionally designed to mislead voters are not acceptable.

party preference information: For a partisan office, you may choose to state a political party that you personally prefer. A preference does not imply that you have been nominated or endorsed by the party, or that the party approves of or associates with you.

If you choose to state a party preference, enter the name of the party (limited to 16 characters).

Your party preference will appear in parentheses below your name. The first letter of each word or abbreviation will be capitalized (e.g., Democratic or Ind.). Acronyms will be printed in all capital letters.

If you do not choose to state a party preference, "(States No Party Preference)" will be printed on the ballot.

No changes to party preference will be accepted between the primary and the general election.

4. filing fee

Fill in the appropriate circle.

Applicable filing fees must accompany the declaration of candidacy.

If you lack sufficient funds at the time of filing, you may petition per RCW 29A.24.001 / RCW 29A.24.101.

6. oath

Read, sign, and date the oath. The declaration of candidacy is not complete and ready for submission until signed.

Duties and Qualifications of Elected Officials

U.S. Senator, Representative

Duties: The U.S. Constitution assigns the Senate and House of Representatives equal responsibility for declaring war, maintaining the armed forces, assessing taxes, borrowing money, minting currency, regulating commerce, and making all laws necessary for the operation of the government.

Qualifications: A U.S. Senator must be at least 30 years old and a U.S. citizen for nine years. A U.S. Representative must be at least 25 years old and a U.S. citizen for seven years. Both must be residents of the state from which they are elected.

U.S. Constitution, Article 1, Sections 2, 3 & 8

State Senator, State Representative

Duties: Introduce bills during each session of the Legislature. Public hearings are held, issues are debated, and votes are taken. Bills that pass both houses of the Legislature are sent to the Governor for signature.

Qualifications: Candidate must be a citizen of the United States and a qualified voter in the district for which he or she is chosen. Washington State Constitution, Article 2, Section 7, RCW 29A.24.075

County Commissioner

Duties: County Commissioners are the legislative body and chief administrators of the county. Adopt annual budgets and county ordinances for traffic, zoning, planning and public safety. Oversee public works, human services, community development, and parks departments. RCW 36.32

Qualifications: At the time of filing for office, candidate must be registered to vote in the district represented by the office they seek. RCW 29A.24.075

Assessor, Auditor, Clerk, Coroner, Prosecuting Attorney, Sheriff, Treasurer

Duties: The duties and responsibilities of county elected officials are prescribed by the Washington State Constitution and by the Revised Code of Washington for each individual office.

Qualifications: At the time of filing for office, candidate must be registered to vote in the district represented by the office they seek.

County Commissioner and Public Utility District Commissioner candidates must reside within the **defined internal boundaries** of the district.

Prosecuting Attorney Candidates must be registered to vote in Kitsap County and also be admitted to practice in the courts of record of Washington state. RCW 29A.24.075, RCW 36.27 Washington State Constitution, Article 11

Supreme Court Justice

Duties: The Supreme Court reviews laws for consistency with the Constitution.

Qualifications: Candidate must be registered to vote and be admitted to practice in the courts of record of Washington state. Washington State Constitution, Article 4, Section 17

Duties and Qualifications of Elected Officials

Court of Appeals Judge

Duties: The Court of Appeals hears appeals on decisions of lower courts.

Qualifications: Candidate must be registered to vote and be admitted to practice in the courts of record of Washington state. Washington State Constitution, Article 4, Section 17

District Court Judge

Duties: The District Court has criminal jurisdiction over misdemeanor crimes, traffic infractions, criminal traffic and other non-traffic infractions as prescribed by the Washington State Constitution and by the Revised Code of Washington.

Qualifications: Candidate must be registered to vote in Kitsap County and be admitted to practice in the courts of record of Washington state. Washington State Constitution, Article 11, RCW 3.34.060

Public Utility District Commissioner

Duties: Planning and study of the conservation of water and power resources for the people in Kitsap County. Work with the state Legislature and local water districts to manage the supply of water and electricity for all uses.

Qualifications: At the time of filing for office, candidate must be registered to vote in the district represented by the office they seek. RCW 29A.24.075, RCW 54.12.010

Precinct Committee Officer

Duties: Elect a chair and vice chair of their political party's county and legislative district central committees.

Qualifications: At the time of filing for office, candidate must be registered to vote in the precinct represented by the office they seek. RCW 29A.80.041

Publishing a Local Voters' Pamphlet

A printed copy of the Local Voters' Pamphlet is mailed to all households within the election 18 days prior to each Primary and General Election. Statements appear in the printed Local Voters' Pamphlet and Online Ballot Access.

Submitting Your Candidate Statement

You will receive a confirmation email with a link to submit the statement once your candidate filing has been approved. You may use the link provided, or submit your statement directly to Kitsap Elections.

Statements consist of:

1. Photograph
2. Campaign Contact Information
3. Biography
4. Statement

Statement Specifications

- *Italics* may be used for emphasis.
- Bulleted lists, bold, underline, all-caps text and multiple indentations are not allowed and will be reformatted.
- Tables and graphs are not allowed.
- Hyphenated words count as two words unless listed as one word by dictionary.com.
- Statements exceeding the word limit are shortened by deleting full sentences from the end until the limit is reached.
- Statements containing obscene, profane, libelous or defamatory language will be rejected. [RCW 29A.32.090](#)
- Candidate Statements must be limited to statements about the candidate himself or herself. [RCW 29A.32.090](#), [RCW 29A.32.230\(3\)](#)

Submission Deadline

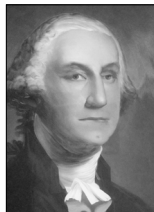
- **May 29:** Deadline for candidates to submit statements, photos.
- A final proof is provided to candidates that must be approved within three business days otherwise it is approved as submitted.

Biography – Elected Experience: President, United States, 1789-1797; Virginia provincial legislator, 1758-1765.

Other Professional Experience: Senior Officer, U.S. Army, 1798-1799; Commander-in-Chief, Continental Army, 1775-1783;

Education: Elementary School-level education achieved through tutors. Trained in mathematics, trigonometry, surveying, drafting and map-making.

Community Service: Delegate to First Continental Congress (1774) and Second Continental Congress (1775).

Statement: The period for a new election of a citizen to administer this elected office being not far distant, and the time actually arrived when your thoughts must be employed in designating the person who is to be clothed with that important trust, it appears to me proper, especially as it may conduce to a more distinct expression of the public voice, that I should now apprise you of the resolution I have formed to beg your consent in returning to elected office.

In office I will promote as an object of primary importance, institutions for the general diffusion of knowledge. In proportion as the structure of a government gives force to public opinion, it is essential that public opinion should be enlightened.

Be assured that this resolution has not been taken without a strict regard to all the considerations appertaining to the relation which binds a dutiful citizen to his country. I have the consolation to believe that, while choice, prudence and the strange reality of my newfound immortality invite me to quit the political scene, patriotism does not forbid my return. I ask for your vote.

1. Photograph

You may submit a self-portrait of your head and shoulders. Use a light-colored background, but not white. Photos must be no more than five years old. A color photo is preferred.

Digital photos must be a minimum 300 dpi resolution and no smaller than 2.5 inches x 3 inches. Your photo may not be digitally altered.

Pins, robes, signage, uniforms or insignias suggesting the wearer has held public office are not allowed. [RCW 29A.32.110](#)

2. Campaign Contact Information

Candidates may submit contact information consisting of a phone number, email address, and website. Contact information does not count towards the word limit.

3. Biography

You may submit a 100-word biography using the following headings, which may be omitted:

Publishing a Local Voters' Pamphlet

A printed copy of the Local Voters' Pamphlet is mailed to all households within the election 18 days prior to each Primary and General Election. Measure arguments appear in the printed Local Voters' Pamphlet and Online Ballot Access. [RCW 29A.32.210-280](#)

Measure arguments are published online only for Special Elections.

Committee Information

The legislative authority of a district that submits a ballot measure must appoint committees to draft arguments 'for' and 'against' the measure. Committees are limited to three members and shall appoint a chairperson as the primary point of contact.

If the district is unable to appoint a committee, they must notify the Auditor's Office in writing. [RCW 29A.32.280](#)

Argument Word Limit

- 250 words (five paragraphs) including no more than four headings.
- Headings may not exceed 15 words and count towards the word limit.
- Headings are printed in bold type.

Rebuttal Word Limit

- 75 words (one paragraph).
- No headings are permitted.
- Rebuttals may only address issues raised in the opposing argument.

Argument and Rebuttal Specifications

- *Italics* may be used for emphasis.
- Bulleted lists, bold, underline, all-caps text and multiple indentations are not allowed and will be reformatted.
- Hyphenated words count as two words unless listed as one word by [dictionary.com](#).
- Photographs and charts are permitted. Each square inch of chart or photograph will substitute for 50 words.
- Arguments and rebuttals exceeding the word limit are shortened by deleting full sentences from the end until the limit is reached.
- Statements containing obscene, profane, libelous or defamatory language will be rejected.

Local Voters' Pamphlet – Measures

1. Ballot Title

The Ballot Title is submitted by the district and reviewed by the Kitsap County Prosecuting Attorney for all districts *except* cities.

2. Explanatory Statement

The Explanatory Statement is prepared by the Kitsap County Prosecuting Attorney for county measures and by the attorney for the district for all other measures.

3. Arguments

Arguments 'for' and 'against' the measure are prepared by committees that are appointed by the district submitting the measure.

Once approved by the Auditor's Office, arguments are transmitted to opposite committees to draft rebuttals.

4. Rebuttals

Committees draft rebuttals to arguments prepared by the opposite committee.

Rebuttals may only address topics presented in the opposite committee's argument and may not introduce new topics.

5. Contact Information

Committee Contact information is optional and may include a committee name, chairperson and member names, website, email, phone number, and mailing address.

Partisan Offices – Primary

A Primary is held if one or more candidates file for a position. [RCW 29A.52.112](#)

Candidates for each office will appear on the ballot in the order determined by lot.

Nonpartisan Offices – Primary

A Primary is held if three or more candidates file for a position. If no more than two candidates file, they appear only on the General Election ballot in the order determined by lot. [RCW 29A.52.220](#)

If No Primary is Held

Candidates for offices that did not appear on the Primary ballot will appear on the General Election ballot in the order determined by lot.

Certification of State Candidates and Measures

The Secretary of State must certify state measures and candidates to appear on the General Election ballot by August 24.

If a Primary is held, candidates for all offices must receive at least 1 percent of the total votes cast for their position in order to appear on the General Election ballot.

- Less than 150 votes, AND
- Less than 1/4 of 1 percent of the votes cast. [RCW 29A.64.021](#),

Requests for a Recount

When a mandatory recount is not required, an officer of a political party or any person who received votes may file a written application for a recount of the votes, or a portion of the votes cast in that election for all candidates for election to that office.

- Any group of five or more registered voters may apply for a recount of the votes or a portion of the votes cast for a ballot measure. The application must specify a manual or machine recount and be submitted no later than two business days after the official certification of the election. [RCW 29A.64.011](#)
- A deposit of \$0.15 for a machine recount or \$0.25 for a manual recount for each ballot cast in the recount shall be made at the time of filing the application. The deposit shall be applied to the cost of the recount and the remaining cost, if any, will be billed to the requester. [RCW 29A.64.030](#)

Filing

All forms, including the C-1 and F-1, may be filed electronically. Candidates spending at least \$5,000 are required to electronically file (e-file) C-3 and C-4 reports. The PDC provides free e-filing tools and blank forms under 'File Online' at pdc.wa.gov. File the C-1, F-1, and other reports only with the PDC – the county filing requirement was eliminated in 2010.

Filing Deadline

File the F-1 and C-1 within two weeks of whichever event happens first: accepting a contribution, spending money on your campaign (including personal funds), reserving space for your campaign, publicly announcing your candidacy, or filing your declaration. C-3 and C-4 reports are filed according to the 2018 Reporting Dates found under 'Important Dates' at the PDC website.

Replacement Ballots

A voter may request a replacement ballot for themselves or any member of their immediate family by contacting the Kitsap County Auditor – Elections Division. [WAC 434-250-080](#)

Early Mail Ballots

Voters who believe they would not receive a regular ballot in time to vote may request an early ballot.

- The request must be provided in writing to the Kitsap County Auditor – Elections Division no earlier than 90 days prior to an election.
- The early ballot contains only those offices, candidates and measures known at the time of the application.
- A regular ballot is also mailed to the voter. If the regular ballot is returned as a voted ballot, it is processed and the early ballot is voided. [RCW 29A.40.050 \(4\)](#), [WAC 434-250-030](#)

Processing Mail Ballots

In order for a ballot to be counted, the voter must sign the declaration on the ballot envelope.

Signed ballot envelopes containing voted ballots must be postmarked by Election Day or delivered to a ballot drop location no later than 8 p.m. on Election Day. [RCW 29A.40.110](#)

Missing Postmark

If the postmark on a ballot envelope is missing or illegible, the signature date determines the date mailed. [RCW 29A.40.110](#)

Validation

Each envelope is examined for postmark and signature. The signature on a return envelope is matched with the voter's registration signature on file. [RCW 29A.40.110](#)

Ballots are mailed to military and overseas voters 45 days prior to a Primary or General Election, or 30 days prior to a Special Election. [RCW 29A.40.070](#)

Military and overseas voters may request to receive their ballots by email. These ballots may be returned via email, fax or standard mail. Ballots returned by email or fax must be received by 8 p.m. on Election Day.

Military and overseas ballots returned by mail do not require a postmark; however, the ballot declaration must be signed and dated by Election Day to be counted.

Online Ballot Access

Online Ballot Access allows registered voters to access ballots and Kitsap County Voters' Pamphlet information electronically.

Through Online Ballot Access, voters may verify if their ballots have been received by Kitsap County Elections using the Ballot Tracker feature.

Online Ballot Access is fully accessible for use by voters with disabilities.

Purchasing Voter Data

Orders may be placed by email, in person, or fax and may require up to three days to complete.

Affidavit

A signed affidavit that voter information will not be used for commercial purposes is required. [RCW 29A.08.740](#)

Format

Information is provided in a text format that is easily imported into programs such as Excel, Access and Word.

Fees

- There is no fee for data sent electronically.
- Voter data sent by mail costs \$0.15 per page, plus postage.
- Payment must be received before the order is fulfilled.

Data Options

Numerous data options are available:

District Choices: All districts and precincts within Kitsap County.

Report Types: Voting record, registered voters, and voters by district are among the many options.

Available Data: Name, address, political jurisdiction, gender, date of birth, voting record, date of registration, and registration number are available.

Voter Registration

Who May Vote

To be eligible to vote, one must register and be:

- A citizen of the United States.
- A legal resident of the state of Washington.
- At least 18 years old on Election Day.
- Not under the authority of the Department of Corrections for a Washington felony conviction.
- Not disqualified from voting due to a court order. [RCW 29A.08.230](#)

How to Register

- Online at vote.wa.gov.
- Complete a mail-in registration form available at libraries, city halls, public schools, fire district offices and at the Kitsap County Auditor's Office.
- When you renew your driver's license.

When to Register

- Individuals may register to vote at any time.
- The following deadlines apply for upcoming elections:

29 days before an election: Deadline for mail and online voter registrations, updates and changes.

8 days before an election: Deadline for new Washington state voter registrations (in person only).

Change of Address

Registered voters that change their residence or mailing address within Kitsap County may provide the new address to the Elections Division. [RCW 29A.08.410](#)

Name Change

If you have legally changed your name, complete a new voter registration application, or provide the information that is on an application: name, residence and an updated signature. Your new signature is used to validate your ballot. [RCW 29A.08.440](#)

To Cancel Your Voter Registration

A voter must provide a signed request to cancel his or her registration. In the case of a deceased voter, a family member may provide written and signed authorization to request cancellation. [RCW 29A.08.510\(3\)](#)

On July 1, **2019**, new voter registration rules will allow for same-day voter registration and for Washington residents 16 and older to pre-register to vote.

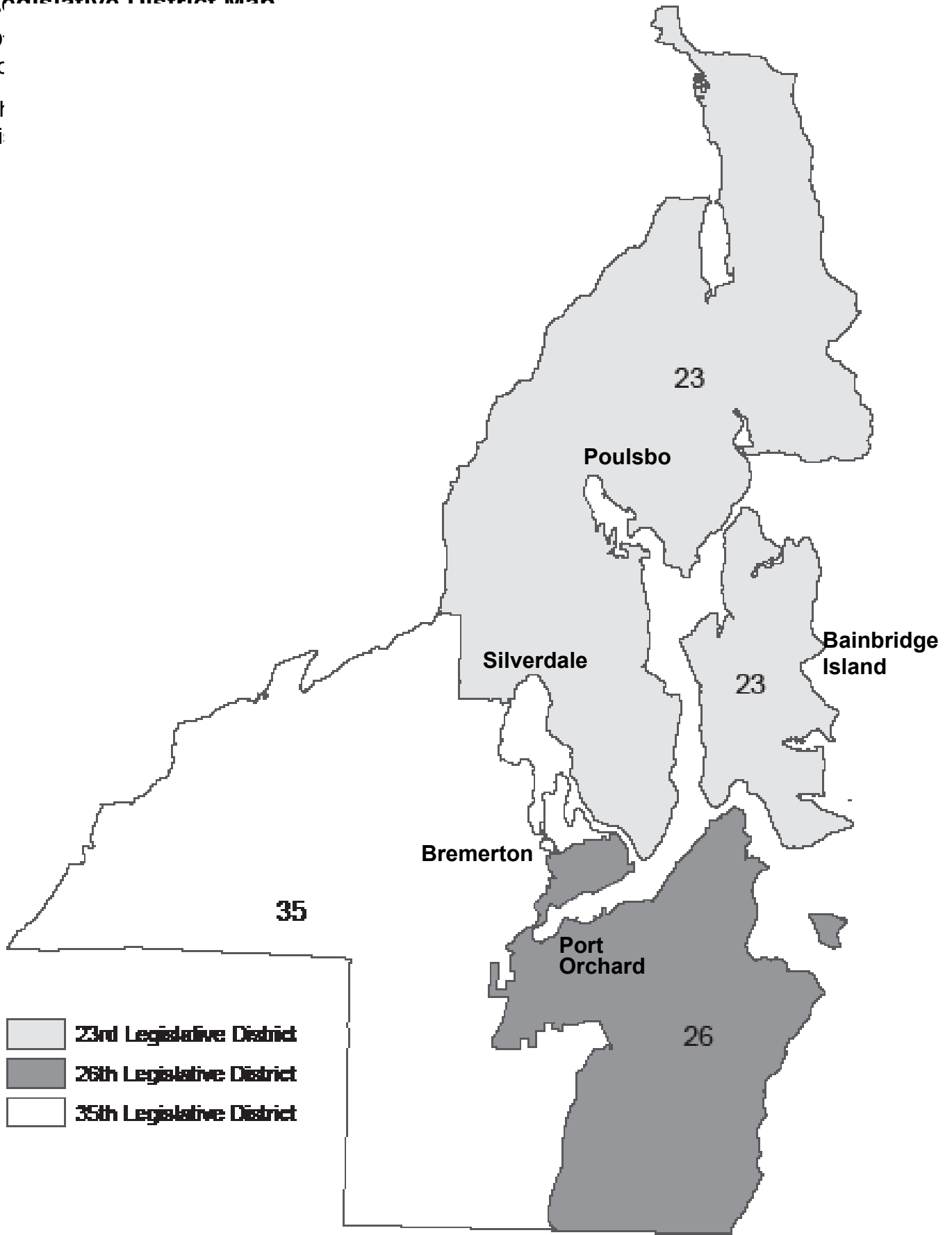

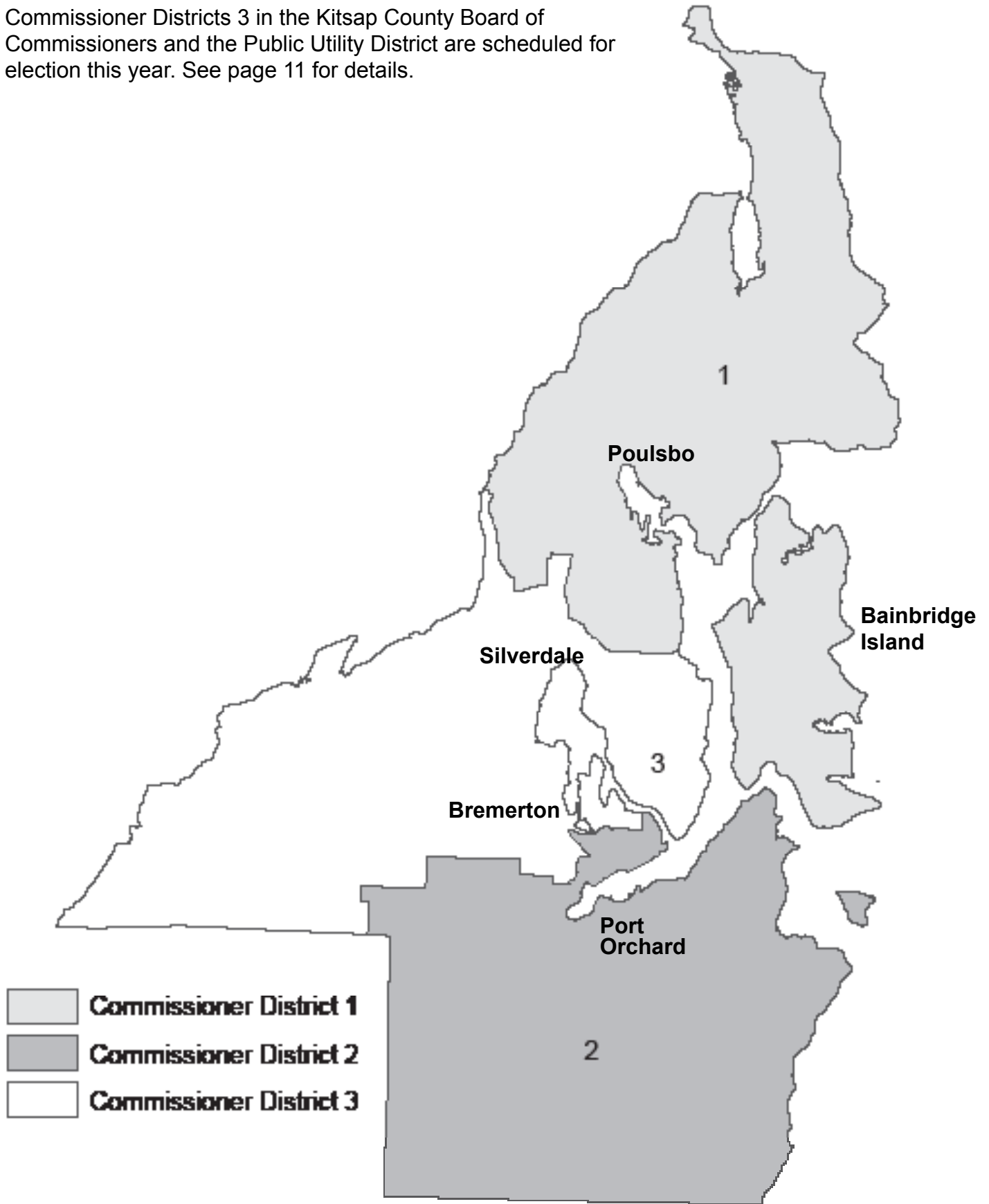
