**South Kitsap School District No. 402**

**Proposition No. 1  
School Support Replacement Levy**

The Board of Directors of South Kitsap School District No. 402 adopted Resolution No. 1059, concerning a proposition to support educational programs and operation expenses. This proposition would authorize the District to levy the following excess taxes, in place of an expiring levy, upon all taxable property within the District, for support of the District's General Fund school programs and operation expenses:

**Proposition No. 1  
Replacement Educational  
Maintenance and Operations Levy**

The Board of Directors adopted Resolution #15-G-08 concerning educational funding. This proposition authorizes the District to levy the following excess taxes, to replace an expiring levy, on all taxable property within the district, to support the District's educational maintenance and operations:

**North Mason School District No. 403**

**Proposition No. 2  
General Obligation Bonds -  
\$54,580,000**

The Board of Directors of North Mason School District #403 approved a proposition for bonds to construct a middle school, high school gymnasium and multi-purpose room; renovate North Mason High; convert part of Hawkins Middle School, rearrange traffic at Belfair Elementary and other capital improvements; to issue \$54,580,000 of general obligation bonds maturing within a maximum term of 30 years, and levy additional property taxes annually to repay the bonds, as described in Resolution #16-G-08.
