COOPERATIVE PURCHASING AGREEMENT

In accordance with chapter 39.34 RCW, the Housing Authority of the City of Bremerton agrees to a cooperative governmental purchasing agreement for various equipment, services and supplies Kitsap County's competitively awarded contracts.

Kitsap County therefore extends the use of its contracts to the Housing Authority of the City of Bremerton to the extent provided by law and upon the following terms:

- (1) The vendor (s) agree to extend to the Housing Authority of the City of Bremerton the terms and conditions of Kitsap County's contract (s).
- (2) The Housing Authority of the City of Bremerton accepts responsibility for compliance with any additional or varying laws and regulations governing its purchases. Any purchases by the Housing Authority of the City of Bremerton shall be effected by a purchase order from the Housing Authority of the City of Bremerton and directed to the vendor.
- (3) Kitsap County accepts no responsibility for the performance of any of the purchasing contract (s) by the vendors (s).
- (4) Kitsap County accepts no responsibility for payment of the purchase price by the Housing Authority of the City of Bremerton.

This agreement may be revoked at any time in writing by either party.


