

**CONTRACT AMENDMENT
A**

This CONTRACT AMENDMENT is made and entered into between KITSAP COUNTY, a municipal corporation, with its principal offices at 614 Division Street, Port Orchard, Washington 98366, hereinafter "COUNTY", and Kitsap Care, LLC dba Bremerton Quality Inn and Suites, hereinafter "CONTRACTOR."

In consideration of the mutual benefits and covenants contained herein, the parties agree that their Contract, numbered as Kitsap County Contract No. KC-346-23, executed on 09/11/2023, shall be amended as follows:

1. **SECTION 1.1: TERM AND EFFECTIVE DATE** shall be amended as follows:
 - The Contract will become effective on May 1, 2023 and terminate on December 31, 2024 unless terminated or extended. The Contract may be extended for additional consecutive terms at the mutual agreement of the parties. In no event will the Contract become effective unless and until it is approved and executed by the duly authorized representative of Kitsap County.
2. **SECTION 3.2: Compensation** shall be amended as follows:
 - The maximum amount of compensation paid under the Contract by the County shall not exceed \$3,115,600.
3. **ATTACHMENT A: Scope of WORK** shall be amended as follows:
 - Objective: To rent sixty-six (66) hotel units for the period of May 1, 2023 through December 31, 2024 to be utilized for non-congregate sheltering.
 - Scope: Requirements Sixty-six (66) hotel units for the period of May 1, 2023 through December 31, 2024
4. Except as expressly provided in this Contract Amendment, all other terms and conditions of the original Contract, and any subsequent amendments, addenda or modifications thereto, remain in full force and effect.

This amendment shall be effective upon execution by the parties.




