## Announcement

- Several of our Coalition members and partners have communicated they have contacted LCB re. MJ delivery services in an effort to address policy, practice and enforcement for the safety and protection of our youth and community.
- Target Zero has identified an increase in fatality car crashes. One in February, six since April. Three are possible alcohol related. New videos our re. safe and sober driving.
- State advocacy is in motion to address the current allowances of MJ delivery during COVID as to keep them from becoming permanent.
- The Coalition will continue to seek to secure meeting solutions to meet the needs of the community and our member/participants especially in the face of this challenging time.
- YWCA is holding a 21 Day Racial Equity and Social Injustice Challenge, including a couple of Lunch and Learn opportunities to share with other participants.
- YWCA has an upcoming 30 – hr. Core DV training in August. For more information contact the YWCA.
- Leadership recruitment is underway. All members have been asked to consider supporting the coalition in identifying and/or participating.

## PARTNER HIGHLIGHTS:

- Services throughout the community are continuing to be available on limited hours, web-based platforms and other creative ways to keep connections. All are practicing safety practices and will move forward as restrictions allow.
- Continued efforts to maintain youth engagement are being upheld. This will continue through the summer as options are available.
- Coalition Strategic Plan and Budget have been fully approved. There has been some conversation at the state that we may see additional dollars for prevention, but details and amount are not yet confirmed.
- CCY has fully supported Coalition information dissemination and advocacy. Currently they are working on putting together a virtual training and a youth forum.
- Regular updates on services continue to be shared with the coalition and via county web pages. These announcements will include but not be limited to food programs, COVID updates, virtual and other web-based training and education opportunities, news for major events and activities, and evidence-based programs that are being modified for electronic delivery and participation.
- Zoom platform will continue to be utilized to help support our monthly meetings even after the COVID19 restrictions are lifted. We are hoping to have a face to face option in August but details at this time are not confirmed. This and other meeting information will be sent out in accordance with upcoming COVID restrictions etc. as we become aware.
