December 31, 2022 marks the eighth full year of service delivery for the Treatment Sales Tax (1/10th of 1%) that

augments state funding of mental health and chemical dependency programs and the operation of therapeutic court services in the Kitsap County Community. The Kitsap County Board of Commissioners adopted the Mental Health, Chemical Dependency, and Therapeutic Court Sales Tax on September 23, 2013.

During 2022, over eight million dollars in grant funding provided direct services to over 10,067 individuals needing behavioral health

supports. In spite of the COVID-19 pandemic and aftermath, providers continued to provide comprehensive, yet flexible care to Kitsap County's most vulnerable populations. Significant outcomes in 2022 include:

- Over a thousand students received immediate counseling and crisis intervention services.
- 91% of Domestic Violence Survivors received intensive support services and support to create new lives.
- 412 individuals moved from jail to wrap around services to create new patterns of behavior and accepted treatment services.

Success Story:West Sound Treatment

Young mother with a 3 month baby

Alondra completed an intake for treatment as instructed to be eligible for housing, she was adamant about getting her 3-month daughter back and providing a better life for them both. Wanting to desperately avoid old behaviors or being homeless. She made huge leaps from the broken woman who began this program. She got got her CPS case closed due to following through with all requirements. Alondra got a job working in management at Subway and obtained a car that is fully legal. Although it has been difficult, she left an abusive relationship and has really began to thrive. She has met most of her goals and maybe even exceeded what she thought she could do thus far. She is now working on getting her 11 year old daughter back. Overall, she has not only given all her dedication and willingness to remain sober and change her life forever but she shows understanding the value of a life she is experiencing for the first time.

2022 Outcomes Related to the Kitsap County Board of Commissioner's Strategic Goals

Goal 1: Improve the health status and well-being of Kitsap County residents.

- ♦ Hundreds of free counseling sessions were offered to those in crisis.
- Over 261 children received intensive wrap around services including supports with a Mental Health Therapist.

Goal 2: Reduce the incident and severity of chemical dependency and/or mental health disorders in adults and youth.

- ♦ 308 animal assisted and telehealth sessions offered to students and families.
- ♦ 233 clients were transported from jail straight into treatment

Goal 3: Divert chemically dependent and mentally ill youth and adults from initial or further criminal justice system involvement.

♦ Crisis Intervention Officer served 386 unduplicated individuals in crisis. He was able to connect 159 of those clients with DCR -Designated Crisis Responder.

♦ Ninety one individuals with co-occuring diagnosis were connected to mental heath services.

Goal 4: Reduce the number of people in Kitsap County who cycle through the criminal justice systems, including jails and prisons.

- Behavioral Health Court had two participants graduate.
- ♦ 70% of Behavioral Health Clients were referred to services, with zero re-offenderes.
- 99 active Drug Courts diversion participants

Goal 5: Reduce the number of people in Kitsap County who use costly interventions, including hospitals, emergency rooms, and crisis services.

- ◆ 120 individuals have been housed and connected to Substance Use Disorder Professionals for multiple sessions and ongoing support
- ♦ 680 Crisis health calls responded to through the Bremerton Health Outreach Program
- City of Poulsbo CARES Unit conducted 12M home visits

Goal 6: Increase the number of stable housing options for chemically dependent and mentally ill residents of Kitsap County.

2022 Kitsap County Continuum of Care

Kitsap County uses a comprehensive approach to addressing behavioral health issues at all levels, including prevention; early intervention; crisis intervention; outpatient treatment; medical and sub-acute detox; acute inpatient care; and recovery support services. The following programs received funding to address the full continuum of care.

Prevention and Early Intervention

Kitsap Public Health District — \$215,668 in grant funds increased the capacity of the Nurse Family Partnership Program and provided services for 12 additional families and outreach to 57 mothers.

Coffee Oasis- \$289,626 in grant funds provided youth intervention services

Olympic Educational Service District 114—\$699,193 in grant funds provided school-based behavioral health services for 608 students.

Crisis Intervention and Triage

City of Bremerton - \$50,000 to provide a behavioral health navigator

City of Poulsbo — \$85,457 in grant funds provided Kitsap Fire CARES mobile unit based at Poulsbo Fire Department who responded to 400 high utilizers with behavioral health issues.

Kitsap County Sheriff's Office— \$493,414 in grant funds covered crisis intervention training, a reentry program, and a crisis intervention officer.

Peninsula Community Health Services — \$294,517 in grant funds provided mental health and substance use intervention for 125 students

Outpatient

Agape Unlimited — \$209,392 in grant funds provided co-occurring disorder services for 35 clients on site at Agape

Kitsap County Juvenile Services Department — \$195,238 in grant funds improved the continuity of treatment services to 155 participants in the Individualized Treatment and Youth Drug Court.

Kitsap County District Court — \$341,035 in grant funds served 43 individuals and provided clinical, compliance and public defense support for their Behavioral Health Court.

Kitsap County Prosecuting Attorney — \$297,696 in grant funds supported their increasing responsibility for all therapeutic-courts, referring 138 individuals to therapeutic court programs.

Kitsap County Superior Court — \$578,590 in grant funds expanded the capacity of the Adult Felony Drug Court serving 175 participants. A total of 23 veterans

Recovery Support Services

One Heart Wild— \$ 132,600 in grant funds provided animal assisted counseling and therapy supports

Kitsap Community Resources — \$684,055 in grant funds provided outreach, rental assistance, and behavioral health referrals for 240 individuals struggling with behavioral health issues.

Kitsap Homes of Compassion—\$345,000 in grant funds provided on-site behavioral health services to 184 by a Behavioral Health Specialist at Kitsap Homes of Compassion housing.

Kitsap Rescue Mission — \$99,925 in grant funds provided on-site behavioral health services to 100 Individuals by a Behavioral Health Specialist's at the Kitsap Rescue Mission.

Scarlet Road — \$75,000 in grant funds provided flexible rental assistance program for 20 adult victims of sex trafficking and sexual exploitation in Kitsap County.

West Sound Treatment Center — \$450,951 in grant funds provided Substance Use Disorder and Reentry Services for 375 inmates in the jail, housing, and supportive services for 565 co-occurring disorder services, and 52 men and women through the New Start men and women's houses.

Success Story: Kitsap Community Resources

Booker has been chronically homeless for many, many years when KCR began working with him, and he had serious mental health issues, and chronic and severe substance use disorder. Typically, he slept on doorsteps of businesses, as his behavior had gotten him kicked out of most local shelters. He had been in and out of various KCR programs over the years, but none of them offered enough to serve Booker in the way he needed. In 2017 we started working with him more intensely, partnering the CHG funded Rapid Rehousing program with the newly created Kitsap Homes of Compassion, where he stayed in a shared house with other homeless men for about six months, before he was asked to leave that house due to drug use, hygiene, and cleanliness issues. He was homeless again for another few months, and then was referred to the ROAST team as a Housing Solutions Center High Barrier client. Through ROAST, he was connected with one case manager who was committed to working with him long term. This case manager got Booker into a motel, where he lived for over a year. It was at this point that he began to stabilize. His drug use reduced, and he was able to settle into living indoors in a place he didn't have to share with others, and he was successful.



Numbers of individuals served compared to individuals mapped will not match up because programs like Partners in Memory Care and Crisis Intervention Coordinator used zip codes of interactions, not unduplicated by individuals.

The Kitsap County Sheriff's Office for Crisis Intervention and Triage for Law Enforcement 98315 tracks officers provided with training by area not zip code. In 2021, 4 Bainbridge Island, 10 Bremerton, 44 Kitsap County Sheriff, 2 Port Orchard, 19 Poulsbo, 1 Port Gamble. 3 Suguamish, and 26 other officers

were trained.

Success Story: Kitsap County Superior Court Adult Drug Court

Last school year, the SAP was referred a student after violating the school drug and alcohol policy. The student was struggling socially and academically frequently, and would often turn to high-risk behaviors such as self-harm and substance abuse. From the start, the student very open to working on their mental health and substance use issues with the SAP. The student participated in the Insight group and relied on the SAP's services throughout most of the school year. The student set many goals and stayed focused on developing healthy coping skills and making good choices. Although there were a few setbacks, the student persevered and kept moving forward. This school year the student is now attending West Sound Tech for half of the day, passing all of their classes and was nominated for a student of the month award.
