A provision will be included in the Final Order of Vacation stating that an easement is retained in respect to the vacated land for the construction, repair, and maintenance of public utilities and services, which at the time the Final Order of Vacation is adopted are authorized or are physically located on a portion of the land being vacated. The term "public utility" as used in this section shall include utilities owned, operated, or maintained by every gas company, electrical company, telephone company, telegraph company, and water company whether or not such company is privately owned or owned by a governmental entity (RCW 36.87.140).
