GAL Statement of Procedures and Fees¹

In this information sheet we try to cover the issues that come up repeatedly in doing parental access evaluations and Guardian Ad Litem investigations. Please take time to read through it and then feel free to ask questions in our initial appointment.

It is important that you understand in advance that this is an evaluation for legal purposes and that your children will be my only concern. There is a possibility that our impression may be unfavorable to your legal position. It is a very difficult and sometimes painful task to make recommendations concerning parent-child relationships. But that is what you are hiring me to do.

The evaluation itself will consist of interview(s) with each parent. Children may be interviewed separately and/or observed in a brief session with each parent or at a home visit, depending on the children's ages. Personality inventories and questionnaires may be administered to the parents. This allows us to collect a wide range of data and organize the issues while minimizing the cost to you. At the end of the evaluation a report and recommendation will be provided to your attorney.

We recognize that our impressions are very important to you. However, please do not ask us to give you an opinion until we have had the opportunity to hear all sides and fully review information. At that time feedback will be given to the attorneys in written form. Once the evaluation has begun we cannot be a resource to you or anyone else involved in the case for advice, therapy or support. These activities conflict with our role as non-partisan evaluator. However, we strongly advise parties to seek therapy elsewhere if they would find it beneficial.

Before we begin the evaluation you will be asked to sign "Release of Information" forms. This allows me to discuss this situation with anyone we think would be helpful to us in forming recommendations or managing your case. It also allows us to talk with the attorneys and submit reports to the court. The laws of confidentiality might otherwise prevent us from doing so.

Parents will NOT have confidentiality with regard to what is said in interview or in their submitted paperwork. Nor do your references. Your children will also not have confidentiality but I may choose to not incorporate their statement into our written findings. I do this in an attempt to buffer them from the pain of litigation. I cannot guarantee confidentiality in that your children's statements may need to be told us on a case-by-case or issue-by-issue basis with each child. Again, it is important to understand in advance that the children are our clients and their interests come first. In the event there is evidence of child abuse or neglect, the law requires that I report to the proper authorities.

The retainer fee for a Guardian Ad Litem investigation is \$5,000.00. This is a credit balance against which fees will be charged. Unused payment will be refunded promptly at the end of litigation. However, your charges may be higher than the retainer, subject to approval by the court.

¹ This is NOT a free agreement. Fees are decided by the court and written in my appointment order. This is however, disclosure of fees involved.

With regard to fees, the cost of an evaluation is often high and difficult to predict. My fee is \$150.00 for a hour and you will be charged for face-to-face contact, phone call with you and your references, email, travel, consultation with lawyers and other professionals involved in the case, as well as report preparation time. You will also be charged for canceled appointments where 24 hours notice is not given. The costs of an evaluation vary widely with the complexity of the issues and the degree of court involvement.

I sometimes request that parents participate in psychological testing. The costs are usually \$400.00 per person and <u>must be paid to Joe Jensen, Ph.D. at the time of service.</u> Referrals to other psychologists are possible. Often times testing will not be necessary.

If your attorney requests a copy of our case file in discovery, you will be charged 80 cents per page and a ten-day notice is required. The cost of the records must be paid **prior** to our releasing them and should be included with your attorney's request. If the records subpoena requires us to appear at your attorney's office, a flat rate of \$300.00 will be charged and must be paid **prior** to our delivering the file. The attorney is able to come to our office and review the file (during the legal action), providing seven days notice is given.

The policies and procedures described in this form have been developed to help assure that we are able to direct our evaluation toward a recommendation that is in the best interest of the child or children involved. If after reviewing this information you have questions, please be sure to discuss them with us at your initial interview when we will more fully explain the evaluation process you are about to begin.
