Community Notification: Level III Sex Offender

PORT ORCHARD, Wash. -- The Kitsap County Sheriff's Office is releasing the following information pursuant to RCW 4.24.550, and a Washington State Supreme Court decision in *State vs. Ward*, regarding public notification of the anticipated residency of a convicted sexual offender.

"The person named in this advisory has been convicted of a criminal offense that requires registration with the sheriff's office in the county of residence," said Sheriff Gary Simpson. "Further, his previous criminal history places him in a classification level that reflects the *potential* to re-offend."

Name: Dillon William Pariseau, white male, age 24.

Residence location: Mr. Pariseau has notified the Kitsap County Sheriff's Office of a residential address change. He now will be residing at a residence in the 10000 block of Banner Road SE, in South Kitsap.

A community notification meeting concerning Dillon William Pariseau was previously scheduled to be held April 1 at Givens Community Center, Port Orchard.

Residences in the Banner Road surrounding area were notified of the meeting by postcard.

Due to precautionary measures concerning COVID-19 transmission, the community meeting concerning Mr. Pariseau's residential address has been canceled. The community meeting will not be re-scheduled. Description:

Height: 5' 07" Weight: 180 lbs.

Hair: brown Eyes: brown

Criminal history: Mr. Pariseau was convicted in 2008, at age 13, of two counts of child molestation, 1st degree, for molesting two seven-year-old girls who were known to him. In 2013, at age 17, Mr. Pariseau was convicted of rape of a child, 2nd degree, after having a sexual relationship with a 13-year-old girl who was known to him.

Additional information: As of March 9, there are 22,372 sex offenders who have registered as required and are living in Washington state. Of this number, 807 are registered with Kitsap County Sheriff's Office.

Dillon Pariseau has served the sentences imposed on him by the courts. He has advised the sheriff's office where he will be living within Kitsap County. This person is not wanted by law enforcement at this time. This notification is not intended to increase fear. Rather, an informed public is a safer public.

The sheriff's office has no legal authority to direct where registered sex offenders may or may not reside. Unless court-ordered restrictions exist, registered sex offenders are constitutionally free to live wherever they choose.

Abuse of information provided through the sex offender notification process, to intimidate, harass or threaten registered offenders, will result in an investigation and the filing of criminal charges against the perpetrators.
