Our Responsibilities

When the Treasurer's Office processes a Real Estate Excise Tax Affidavit, they are only checking that the affidavit is completed to match the legal document that is being recorded. They are not legally qualified to interpret the document or the effect it will have once it is recorded.

The Treasurer's Office is merely acting as an agent for the Department of Revenue when processing the Real Estate Excise Tax Affidavit. They can assist with choosing a Washington Administrative Code (WAC) that may apply to the transfer of property however, it is the involved parties' obligation to prove the validity of the WAC chosen when their transaction is audited by the Department of Revenue.

If you are involved in transferring real property and you are not familiar with the document types and how to complete them, it is in your best interest to contact a title company or attorney to be certain you are accomplishing what you wish to accomplish. The Treasurer's Office can only assist with the completion of the Real Estate Excise Tax Affidavit and cannot assist with the proper completion of the legal document or advise on what type of document to use.
