16-05779: Bayshore and Washington Improvement Projects, Shoreline Substantial Development Permit Commercial (SSDP – COM)

**Project Description:** Replacement of approximately 1,900 lineal feet of existing sewer mains, side sewers located sub-grade, associated manholes inclusive of stormwater facilities within County right of way on Bay Shore Drive & Washington Avenue. Planned drainage improvements for this area will replace existing pipes with CPEP product, modular wetland bio-retention boxes and control facilities. Drainage improvements also include NW Byron Street. Water mains and connection will also be completed, including improvements for non-motorized travel, sidewalks, bicycle lanes and street lighting safety improvements. No stormwater outfall improvements planned at this time. As proposed construction involves deep-trenching, shoring & dewatering, a NPDES sedimentation control plan will be required.
