18-00261: Danubio Shoreline Variance (SVAR)

Project Description: Proposed project is 1,704 sq. ft residence aligned parallel to the shorelines Ordinary High Water Mark (OHWM). Elements of the project include an SDAP for the construction of a retaining wall to the toe-of-slope and landward extent of net buildable area. Due to the dimensions of the property and landward slope, to include the necessary retaining wall, the proposed residence is within the standard and reduced shoreline buffer (85-ft Shoreline Residential). The historic use is non-conforming. The project requests a shoreline variance for structural impacts within 75% of the reduced buffer. The structure is set 28-ft from OHWM. Mitigation is provided at ratios higher than the standard required under Appendix B, SMP22.800 Kitsap County. The variance request would result in lawful non-conforming residential use on the Danubio property.

18-00520: Indigo Topsoil – Conditional Use Permit Revision Major (CUP REV MAJOR)

Project Description: Applicant requests a major revision, to the approved Emu Topsoil Conditional Use Permit (CUP) LU-5264 (Hearing Examiner File 970626-015), to operate generally in the previous approved development footprint, and revise the existing CUP

approval to change the scope of work, limit business hours, expand retail sales to include other landscape materials such as mulch, sand, and gravel. Original permit was approved for retail sales of topsoil created by recycling and mixing emu waste from an emu ranch with other soil elements as well as importation of other manure for the same purpose. Soil mixing machine hours were limited to 8:00 am to 5:00 pm and retail sales from 7:00 am to 6:00 pm 7 days a week. Indigo Topsoil is proposing 8:00 am to 5:00 pm Monday thru Friday, and Saturday 8:00 to 4:00 pm.
