Permit #19-03805: KRM Quarry - CUP Revision

Project Description: The application proposes to increase that maximum mine depth to 20' in an 11-acre portion of the existing 96-acre KRM Quarry. This is a major revision and expansion to a Conditional Use Permit (CUP) approved in 1996 and a Site Development Activity Permit (SDAP) from 2010. This major amendment changes the original 1996 CUP and 2010 SDAP permit by increasing the maximum depth of the mine from 60-feet to 80 feet.
