- 8 The Kitsap County Planning Commission finds as follows:
- A. Kitsap County is subject to the requirements of the Washington State Growth
 Management Act (GMA), RCW 36.70A.480 'Shorelines of the State.'
- B. On January 30, 2013 (Ordinance # 502-2013), Kitsap County completed a comprehensive update to the SMP as required by law. This comprehensive SMP update review included but was not limited to assessment of ecological functions, baseline conditions, and SMP environmental designations. This local adoption was approved by the Washington State Department of Ecology (Ecology) on December 24, 2014.
- C. The Washington State Shoreline Management Act (SMA), RCW 90.58.080 (4)(a)(ii), mandates Kitsap County shall periodically review its SMP every 8-years. This periodic update is due June 30, 2021. The purpose of this periodic review is to update the local SMP to reflect changes to state law and associated rules and guidance, ensure internal consistency with the Kitsap County Comprehensive Plan and associated development regulations, as well as provide an opportunity to improve usability and predictability of the SMP.
- D. The GMA, RCW 36.70A.130(1), also mandates that Kitsap County's Comprehensive Plan and development regulations are subject to continuing review and evaluation.
- E. RCW 36.32.120(7) provides that the county legislative authorities shall make and enforce, by appropriate resolutions or ordinances, all such police and sanitary regulations as are not in conflict with state law.
- F. Kitsap County Code (KCC) Chapter 21.08 sets forth a process and criteria for making amendments to development regulations. Specifically, KCC 21.08.100 outlines review by the Kitsap County Planning Commission. In its making recommendations, the Planning Commission shall consider.
 - a. whether the proposal is supported by the capital facility plan;
 - b. whether the proposal is consistent with the requirements of the GMA, Kitsap Countywide Planning Policies or other applicable laws or provisions of the Comprehensive Plan;
 - c. whether the proposal reflects current local circumstances; and

1 2 2	d. whether the proposal bears a substantial relationship to the public's general health, safety, morals or welfare.

With the assistance of a consultant and development of a consistency analysis, Kitsap County Department of Community Development (Department) proposed amendments to KCC Titles 15 (Flood Hazard Areas), Title 19 (Critical Area Ordinance), Title 21 (Land Use and Development Procedures) and Title 22 (Shoreline Master Program).
8 9 10	H. Following review and approval by the Kitsap County Board of Commissioners, a public participation plan and consistency analysis was developed to aid in developing the draft amendments.
11	Section 2. General Procedural Findings.
12	The Kitsap County Planning Commission finds as follows:
13 14 15	 On October 20, 2020, following timely and effective notice, the Planning Commission was briefed on the scope of work and timeline for the Shoreline Master Program periodic review process.

On October 28, 2020, following timely and effective notice, the Board of County Commissioners reviewed and approved the Shoreline Master Program Periodic Review Public Participation Plan. The Public Participation Plan was submitted to Ecology (see staff report Attachment D1). Public outreach regarding the proposed amendments was conducted through:

On November 17, 2020, Department staff sent an electronic notification via GovDelivery announcement to all subscribers of the SMP topic, Commissioner District newsletters, and numerous code update topic subscribers announcing the kick-off of the SMP periodic review process and how to participate and stay engaged.

2 of 5 3/30/2021 4. On November 17, 2020, following timely and effective notice, the Planning Commission was briefed on the Shoreline Master Program Periodic Review Public Participation Plan and the goal to conduct early and often public outreach and education about the periodic review process.

- 5. On November 25, 2020, following timely and effective notice, the Board of County Commissioners reviewed and approved a proposed scope of code amendments noted in the Consistency Analysis Report. As a first step in determining the extent of the proposed amendments for periodic review process, the County, with the consultant support, identified gaps in consistency with state laws using Ecology's periodic review checklist, gaps in consistency with the County Comprehensive Plan and associated development regulations, as well as revisions to improve usability and predictability (see Attachment A1 of the staff report).
- 6. On December 1, 2020, following timely and effective notice, the Department staff briefed the Planning Commission on proposed code amendments to the Shoreline Master Program and related codes based on the Consistency Analysis Report.
 - 7. On December 5, 2020, Department staff sent via email the Consistency Analysis Report to partners and interested parties listed in section 5 of the Shoreline Master Program periodic review Public Participation Plan.
- 8. On December 17, 2020, following timely and effective notice, the Department staff conducted the first virtual monthly project update meeting about the Shoreline Master Program periodic review process and launched the SMP online open house.
- 9. In January 2020, following timely and effective notice, the Department staff provided numerous briefings and outreach to the County's citizen advisory groups, tribes, and community groups and organizations as outlined in Section 7 of the staff report.
- 10. On January 19, 2021, following timely and effective notice, the Department staff provided a status update, and reviewed with the Planning Commission, preliminary approaches for draft amendments to several sections of the Shoreline Master Program and related codes.
 - 11. On January 21, 2021, following timely and effective notice, the Department staff conducted the second virtual monthly project update meeting about the Shoreline Master Program periodic review process, update on development of code amendments and upcoming joint public comment period.
- 12. On January 25, 2021, following timely and effective notice, Department staff reviewed
 and discussed with the Board of County Commissioners preliminary approaches to all
 proposed draft amendments to the Shoreline Master Program and related codes to kick off discussions and receive initial feedback.
- 13. On January 27, 2021, following timely and effective notice, the Department staff
 provided a status update and shared with the Planning Commission the project webpage

- draft amendments proposed in KCC Titles 15, 19, 21, and 22. This was in advance of the formal 30-day joint public comment period with the Planning Commission and Ecology of February 2 to March 3, 2021.
- 14. On January 28, 2021, Department staff sent out an electronic notification about the public comment period and public hearing via GovDelivery and NextDoor to SMP topic subscribers, District newsletters, and numerous code update topics on the proposed amendments to KCC Titles 15, 19, 21 and 22. The Department also sent formal letters via email to partners and interested parties including tribes, cities, counties, special districts, community group, environmental groups, and state and federal agencies.

- 15. On February 2, 2021, following timely and effective notice, the Planning Commission held a work study session on the proposed draft amendments to the Shoreline Master Program and related codes. Department staff provided an overview of the proposed code amendments Titles 15, 19, 21, and 22.
- 16. On February 5, 2021, Department staff submitted a 60-day notice of intent to adopt amendment to Washington State Department of Commerce. The Department is awaiting comments from Department of Commerce.
- 17. On February 16, 2021, following timely and effective notice, the Planning Commission held a second work study session on the proposed draft amendments to the Shoreline Master Program and related codes. This was an opportunity to discuss the proposed draft amendments prior to the March 2, 2021 joint public hearing Ecology and subsequent deliberations.
- 18. On February 18, 2021, Kitsap County issued a State Environmental Policy Act (SEPA) Determination of Nonsignificance (DNS) per WAC-197-11-340(2). The SEPA comment and appeal period closed on March 4, 2021. The Department received one SEPA comment letter, from the Suquamish Tribe, which also served as the Tribe's comment letter for the Shoreline Master Program draft proposed amendments and related codes.
- 19. On February 18, 2021, following timely and effective notice, the Department staff conducted the third virtual monthly project update meeting about the Shoreline Master Program periodic review process, update on joint public comment period.
- 20. On March 2, 2021, following timely and effective notice, the Planning Commission held a joint public hearing with the Department of Ecology to consider testimony on the proposed draft amendments to the Shoreline Master Program and related codes.
- 21. On March 3, 2021 at 5:00 p.m., the joint public comment period with Ecology and the Planning Commission closed. Twenty comment submittals were received through emails, online submittals, and verbal testimony.
- 22. On March 16, 2021, following timely and effective notice, the Planning Commission held
 its first deliberation meeting to review and deliberate on public comments received and
 Department recommendations.
