

## CONTRACT AMENDMENT C

This CONTRACT AMENDMENT is made and entered into between SALISH BEHAVIORAL HEALTH ADMINISTRATIVE SERVICES ORGANIZATION, through Kitsap County, as its administrative entity, a political subdivision of the State of Washington, with its principal offices at 614 Division Street, Port Orchard, Washington 98366, hereinafter "SBH-ASO", and Kitsap Mental Health Services hereinafter "CONTRACTOR."

In consideration of the mutual benefits and covenants contained herein, the parties agree that their Contract, numbered as Kitsap County Contract No. KC-136-20, executed on May 11, 2020, and amended on September 14, 2020 and November 9, 2020, shall be amended as follows:

- Page 1 shall be amended as follows:

**Contract Amount** is increased by \$2,500, increasing the contract total from \$252,660 to \$255,160.

**Contract end date** remains January 1, 2020 to June 30, 2021.

2. **Attachment C Budget** is deleted and replaced in its entirety as attached.

Services Team funding

1/1/20-6/30/20 funding remains unchanged at \$81,020.

7/1/20-6/30/21 funding remains unchanged at \$171,640.

3/1/21-6/30/21 increases funding for HARPS SABG support by \$2,500 from \$0 to \$2,500.

3. If this Contract Amendment extends the expiration date of the Contract, then the Contractor shall provide an updated certificate of insurance evidencing that any required insurance coverages are in effect through the new contract expiration date. The Contractor shall submit the certificate of insurance to:

Upon receipt, the Human Services Department will ensure submission of all insurance documentation to the Risk Management Division, Kitsap County Department of Administrative Services.


4. Except as expressly provided in this Contract Amendment, all other terms and conditions of the original Contract, and any subsequent amendments, addenda or modifications thereto, remain in full force and effect.

This amendment shall be effective March 1, 2020.

# **SOW Services for HARPS Substance Abuse Block Grant**

**Revised March 3, 2021**

- 1. Statement of Work.** The Contractor must provide recovery supports to individuals who meet HARPS eligibility and have a substance use disorder. Recovery supports are provided to support access to treatment services. Contractors will consider priority populations listed in 2 below. Recovery supports will be provided as listed in items 3 and 4 below.
  
- 2. HARPS Priority Populations**
  - a. Pregnant women and women with dependent children
  - b. Intravenous drug users
  - c. Tuberculosis services
  - d. Early intervention services for HIV/AIDS
  - e. Primary prevention services
  
- 3. Basic Needs**
  - a. Food – gift cards in small amounts for use before/after treatment appointments or prevention activities
  - b. Minutes on phones - if being used for telehealth appointments related to treatment or prevention activities
  
- 4. Transportation**
  - a. Bus Passes, Ferry Passes, Light Rail Passes, ORCA Cards in order to attend treatment or prevention activities
  - b. Gas voucher – small amounts only in order to attend treatment or prevention activities
