

- Guest Speaker: Kirsten Jewell, Kitsap County Housing & Homeless Division Manager spoke to us about Veteran homelessness in Kitsap County. Her presentation is attached as part of the official minutes for the meeting. In 2020, 124 Veteran households requested housing assistance. For people seeking housing assistance, the entry program is designed to make it a one-stop shop for processing all housing needs. They partner with area organizations to provide temporary housing solutions including Building 10 at Retsil, Salvation Army, the temporary shelter at the County Fairgrounds, Kitsap Community Resources, Oxford House and Homes of Compassion. She talked about the new shelter in Port Orchard on Mile Hill drive.

Reports:

- a. Veterans Assistance Fund (VAF). Doug Washburn stated we are in a good position to get us through the end of the year. We will have a detailed financial briefing at the November Retreat.
- b. Committee Reports (Five Minutes Each)
 - Tiny Houses Nothing new to report on tiny homes.
 - Veterans Garden Dennis asked Doug for help on the Howe Management Farm plan from 2003. Joe Kochera volunteered to help with the update of the plan.
 - Public Affairs Officer Nothing new to report
 - Military Appreciation Day September 25 at the Kitsap Pavilion at the Fairgrounds.
 Joe encouraged VAB members to stop by the event. Harry volunteered to staff the VAB table during the event.
 - Veteran Day November 11, Kitsap Pavilion. More info to follow.
 - Social Media Brian posted the cooling sites available in Kitsap County during the heat wave.
 - Suicide Prevention Rick provided an update of the COVID cases at Retsil. Due to the increase of COVID cases in the County, Rick proposed we cancel the Suicide Prevention event scheduled for September 10. A motion was made by Harry and seconded by Rick. Discussion was held to get an interview and/or ad in The Kitsap

Sun to address Suicide Prevention. Joe made a motion and seconded by George to approve a ½ page ad. I will work with Sonya to come up with an ad for the paper.

- Women's Resource Group Nothing new to report
- CBOC Peggy reported from the monthly CBOC Board meeting. The Leadership was in attendance. They discussed the clinic growth three new providers have been added since the end of May and beginning of June. The plan is to add two more provides in September. Another pharmacists and social worker have been added. An area of concern is the Community Care initiative. This is where a contract with TriWest has been created to connect a Veteran to specialty care needs in the area if the CBOC is unable to provide the service especially nontraditional medical treatment such as herbalist, acupuncture, etc.. Another area of concern is the call center service. Veterans often get different answers to inquiries depending on who answers the phone. The call center service is typically performed by contract services and they are not as familiar with issues and keeping current on Veteran support. The Leadership team asked to Board members to focus on several areas; 1. Transportation from Silverdale to Seattle and American Lake; 2. What would be helpful to have in the clinic, i.e. specialist; and 3. Feedback on telehealth/video visits.








LITERALLY HOMELESS HH SELF-REPORTED CHARACTERISTICS²




LITERALLY HOMELESS HH SELF-REPORTED CHARACTERISTICS²

MINUTES OF THE KITSAP COUNTY VETERAN'S ADVISORY BOARD September 8, 2021 Online meeting

CALL TO ORDER: The meeting was called to order by Boyd Lee at 5:30 PM.

- Announcement Chair read on-line announcement.
- Approval of Agenda: Motion made and seconded to approve agenda.
- **Approval of minutes:** Motion made and seconded to approve minutes with corrections from the August 2021 meeting.
- Guest Speaker Joel Adamson, Homes of Compassion spoke to us about the work they are doing in Kitsap County. In 2019, the VAB approved a donation \$5000 for Homes of Compassion to lease a house designated for Veterans. In December 2019, the men's house opened. Since that time, nine Veterans have been housed with currently four men in the home today. The Board also approved a home designated for women Veterans but there has not been the demand to warrant a dedicated house for women Veterans. Any woman Veteran is housed in one of the currently existing homes.

Joel stated that chronic homelessness is defined as someone that has been homeless more than a year or had three or more instances of periods of homelessness over a specific period of time. There are currently 25 homes with 10 of them dedicated for women. Seven new homes are scheduled for 2021. They are located throughout the County and must be located near a bus stop. They are funded through donations and grants. They are experiencing a decrease in donations resulting in reduction in staffing levels. A Veteran can access residency in one of the homes through KCR, housing solution center where a housing assessment is conducted. A Veteran can also complete an application on the Homes of Compassion website. Joel mentioned they are seeing an increase in demand due to COVID and an increase in real estate making homeless needs more critical. Once in a while there is community push back from leasing a home but there is no requirement to make public disclosure to the community or any special permitting requirements.

Reports:

- a. Veterans Assistance Fund (VAF). A discussion was held regarding filling a financial gap for Homes of Compassion for the Veteran home when a room is vacated. Doug said he would connect with Joel to see what the financial need is to see if its something we can help out with in the near term or whenever there is a vacancy.
- b. Committee Reports (Five Minutes Each)
 - Tiny Houses Clive announced he had a discussion with Commissioner Garrido. She stated the tiny homes will be relocated to CalvinWood, Pilgrim Firs. More info to follow as it becomes available.
 - Veterans Garden No report.
 - Public Affairs Officer Nothing new to report

- Military Appreciation Day Military Appreciation Day has been postponed to Spring 2022.
- Veteran Day November 11, Kitsap Pavilion. Bob announced the first meeting is scheduled for Wed, Sep 15; second meeting scheduled for October 13. The committee is accepting names of organizations wanting a table at the event.
- Social Media No Report.
- Suicide Prevention Rick announced the Suicide Prevention ad was to be in the Friday thru Monday paper. Rick also presented before the Board an opportunity to hold a virtual suicide prevent event. The Board approved researching it and return with a plan to go forward.
- Veteran Education Tatiane reported that Olympic College will require vaccinations for students to participate in onsite campus classes. She also reported attendance is down about 10%. The college is currently serving over 1100 Veterans.

Volunteers were solicitated at two of the sites; Fishline from 1000 1200 Frank Gibbons from 1200-1400 Scott Austin; VA Clinic in Silverdale; Team leader is Joe Kochera; 1000-1200 Harry Gilger, 1200-1400 Rick Becker. Leo Davilacorrea also volunteered to help.

MINUTES OF THE KITSAP COUNTY VETERAN'S ADVISORY BOARD 2021 RETREAT

November 6, 2021 Olympic College

CALL TO ORDER: The meeting was called to order by Peggy Roy at 9:00 AM

- 1. **Approval of Agenda:** Agenda approved as amended.
- 2. Approval of Minutes Tabled until December meeting
- 3. Guest Speakers
 - **a.** Garry Hughes from Kitsap Community Resources (KCR) discussed the process he uses when a Veteran needs assistance.
 - **b.** Samantha Adams from Northwest Justice Project (NWJP) gave a presentation on the accomplishments from the previous year. A copy of the presentation was made available to Board members

5. New Business

- a. Financial Review presented by Rick Becker. Presentation included a review of RCW 73.08 the Washington State guidance on the Veterans Assistance Program (VAP) and how the funds may be used. We looked at the Veteran population projections for Washington and Kitsap County while it shows a decrease for the State of Washington, we actually see a growth for Kitsap County. Rick presented the top 11 items funding is used by the Veteran population through KCR. The increase in rental values, food and utility costs are the biggest concern as we anticipate that will continue for some time. In looking at the trends over the past five years, Veterans and their families are using the program at a steady rate.
- b. Review of RCW restrictions & budget limits- Doug
- c. Homeless update presented by Doug Washburn. The presentation covered veteran homelessness in the County.
- d. Policy & Procedures review lead by George Holden. Outside of some minor administrative changes the major topics discussed were as follows:
 - i. Para 2.6 Income Guidelines: As it currently reads the household income needs to be equal or fall below 175% of current federal poverty rate for the previous 90 days. Garry Hughes reminded us that by increasing the percentage of the currently poverty rate, we actually reduce the total amount of funds a household can get. The Board decided a cost benefit analysis needed to be conducted before we adjust that level. This item will be review in the February 2022 meeting.

- ii. Para 2.8 Unemployed Veterans Work Search Requirement: Currently, an unemployed Veteran must be registered with the Veterans Job Service Section at a local WorkSource office. However, this is not always easy to do. It entails the Veteran to get to the WorkSource office in Silverdale then return to KCR in Bremerton. The question is how best to verify a Veterans unemployment status without the burden of actually visiting the WorkSource office and then returning to Bremerton to get funds needed.
- iii. Para 3.2 Maximum Allocation: Before the sentence Burial and cremation services do not apply ... add the unemployed Veteran must meet the guidelines of para 2.8 Unemployed Veterans – Work Search Requirement.
- iv. Para 3.8 Burial Assistance: Recommend change to the paragraph to state, Burial or cremation of any deceased indigent veteran or deceased family member of the indigent veteran shall abide by the guidelines provided in County Code 29.92.080 Burial or cremation of deceased veterans or family member. The amount of funding to be authorized from the veterans' assistance fund shall not exceed \$1500.
