Indemnity as follows:

1. The contractor shall, at his own expense, carefully replace and repair any damage to the streets, alleys, avenues, highways or public places, and leave the same in as good condition as they were previous to the commencement of the work, and backfilling of trenches per conditions on permit and be guaranteed to hold up for at least the period of time specified for the bond on each individual permit(s).
2. The contractor shall fully protect, defend and save Kitsap County harmless from any damages to persons or property in any manner occasioned, resulting from or arising out of the negligence of said contractor in the use, occupancy or possession of said streets, alleys, avenues, highways or public places.

NOW, THEREFORE, if the above bounden, \_\_\_\_\_, shall fully perform the terms and conditions above set forth then this obligation shall be null and void; otherwise to remain in full force and effect and shall not be released until authorized by Kitsap County Public Works Construction / Inspection Division. If the bonding company has to cancel the bond, they must give Kitsap County Public Works at least ninety (90) days written notice in order for a final inspection to be made.
